3. The Supplier has the right to withdraw credit facilities at any time.
4. The Applicant acknowledges and agrees that The Applicant will be liable for and will pay all amounts charged to the account by employees, servants or agents of The Applicant or any person who purports to be an employee, servant or agent of The Applicant in circumstances where it is reasonable for The Supplier or its employees, servants of agents to believe that the person is authorised by The Applicant to charge purchases to The Applicant's account.
